ROLE AND RESPONSIBILITIES

Cauda Equina Foundation, Inc. is a 501(c)3 charitable nonprofit that serves to improve the quality of life and care for individuals living with cauda equina syndrome. Our Patient and Caregiver Action Committee lead the way to achieving our mission.

- Take care of the organization by ensuring prudent use of all assets, including facility, people, and good will; and provide oversight for all activities that advance the nonprofit's effectiveness and sustainability. (legal "Duty of due care")
- Make decisions in the best interest of the nonprofit corporation; not in his or her self-interest. (legal "Duty of loyalty")
- Ensure that the nonprofit obeys applicable laws and acts in accordance with ethical practices; that the nonprofit adheres to its stated corporate purposes, and that its activities advance its mission. (legal "Duty of obedience
- Serving as a trusted advisor to the foundation as it develops and implements the strategic plan
- Reviewing outcomes and metrics created by Cauda Equina Foundation for evaluating its impact, and regularly measuring its performance and effectiveness using those metrics; reviewing agenda and supporting materials prior to board and committee meetings
- Reviewing the annual budget, audit reports, and material business decisions; being informed of, and meeting all, legal and fiduciary responsibilities
- Assisting the CEO and Board Chair in identifying and recruiting other Board or Committee Members
- Partnering with the foundation staff volunteers to ensure that board resolutions are carried out
- Serving on task forces and taking on special assignments
- Representing Cauda Equina Foundation to stakeholders; acting as an ambassador for the organization and its mission
- Ensuring Cauda Equina Foundation's commitment to a diverse board and staff that reflects the communities we serve
- Providing hands-on leadership to lead the organization to reach its goals.
- Must have regular access to computer, phone, audio/video conference ability, and internet connection
- Other duties as determined by the Board of Directors and the Patient and/or Caregiver Action Committee

FUNDRAISING

Patient and Caregiver Action Committee Members will consider Cauda Equina Foundation a philanthropic priority and make annual gifts that reflect that priority. So that Cauda Equina Foundation can credibly solicit contributions from foundations, organizations, and individuals, we expect to have 100 percent of Action Committee Members make an annual contribution that is commensurate with their capacity.

ACTION COMMITTEE TERMS/PARTICIPATION

Cauda Equina Foundation, Inc. Action Committee Members will serve a two-year term and pending annual review, may be eligible for re-appointment for additional terms. Meetings will be held monthly on a virtual network. Committee meetings will be held in coordination with full board meetings as needed. Meetings will



be a minimum of two-hour events and the annual meeting up to two days on the day(s) and time(s) agreed on at the previous board of directors meeting. The mandatory in person annual meeting is on hold due to COVID-19 and is currently virtual. In the future travel for the annual meeting may be required. There are exemptions for those that cannot travel due to medical reasons.

QUALIFICATIONS AND EDUCATION REQUIREMENTS

Cauda Equina Foundation, Inc. is looking for passionate individuals that want to advance the field of cauda equina syndrome, advocate for those living with the disease, and help the foundation reach its goals and serve its mission. There are currently no minimum education requirements for members on the Patient and Caregiver Action Committee, however, a basic understanding of computers, email, Google and Microsoft programs, and internet usage is necessary. Training will be provided to enhance your ability to carry out your duties and provide educational knowledge of cauda equina syndrome to professionals and patients alike.
